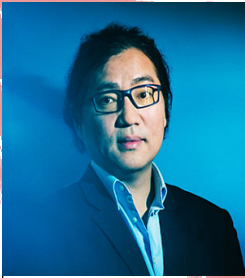

## 2023 ASC Snapshot: KOSCA-sponsored panels

*It was a particularly productive year for KOSCA at ASC.*

*KOSCA sponsored the following five research panels.*

**“Exploring Emerging Trends and Developments in Cybercrime”** panel highlighted the potential risks, motivations, and profiles of cybercrime offenders, including the use of artificial intelligence, hacking services in the Dark Web, and cyber victimization in the healthcare industry.

Another panel focused on **“Preventing Cybercrime: Challenges and Opportunities in Education, Regulation, and Legal Framework.”** The panel provided preventive measures and offered solutions for addressing misleading information by on-line casino reviews, examined the regulatory frameworks in the EU and the US (“Comparative Justice on EU-US Data Privacy Laws on the Prevention of Internet Fraud and Identity Theft”), and emphasized the importance of K-12 education in promoting cybercrime awareness.

The next panel discussed the important and timely topic of **Anti-Asian Hate Crime**. Three papers were presented by the members to discuss 1) the willingness of Korean Americans to report hate crime to the police, 2) the factors influencing anti-immigrant sentiment



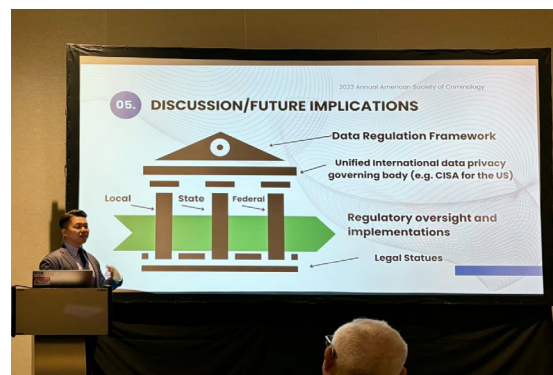
compared between South Koreans and US residents, and 3) hate crime victimization among Korean businesses.



**The comparative perspective on policing structure** was co-sponsored with the **Korean Institute of Criminology and Justice (KICJ)**. Scholars from the KICJ presented papers on “Improving the legitimacy of information collection by the Korean Intelligence Police and its future direction” and “The Special Judicial Police system in the Republic of Korea.” KOSCA scholars presented the papers on “Strengths and weakness of the American Police structure” and “Community policing and citizen participation.”



KOSCA co-sponsored another panel on **Police and Protest** in collaboration with the **Association of Chinese Criminology and Criminal Justice in the United States (ACCCJ)**. The panel addressed the important issues involving police and protest, such as policing strategies and their ramifications.



## KOSCA Annual Meeting at ASC

Our Annual Meeting was held on Thursday, Nov. 16th at The Notary Hotel. The meeting started with formal greetings and a welcoming address from our 7th president, **Dr. Hyeyoung Lim**. Our meeting was honored with congratulatory remarks from **Dr. Cynthia Lum**. After having the general business reports from the committees, divisions, and from the treasurer, **Dr. Craig D. # Dr. Young-An Kim's Insightful Presentation on Research Publication

Dr. Kim's presentation covered the genesis of research ideas, academic writing in English, and time management as graduate students.

First, he highlighted that research ideas emerge from exploration and familiarity with prior literature, underscoring the importance of effective reading for a comprehensive understanding of the field. Documenting ideas and being open to advice are crucial for developing research ideas.



Second, Dr. Kim stressed the importance of clarity in academic writing in English, suggesting strategies such as using the key sentence for the study as a guiding compass and transcribing interesting articles. Lastly, the presentation touched on time management for graduate students. Dr. Kim emphasized the compatibility between coursework and research and the crucial aspect of maintaining well-being while working hard, encouraging the development of personal mechanisms to manage anxiety.

## Research Ideas

The genesis of research ideas and insights lies in exploration and familiarity with prior work in the field. This emphasizes the importance of reading. A comprehensive understanding of the field and what has or has not been done can be achieved through extensive reading. Remember, more input yields more output.

## English Academic Writing

Academic writing in English is difficult not only for international students but also for those whose native language is English, spanning across students and even established professors. Pause and consider whether the challenge lies in English itself. Reflect on whether you genuinely grasp the question and objective of your study. Moreover, beyond linguistic proficiency, the beauty of academic writing lies in clarity.

## Time Management

When it comes to time management as graduate students, the dilemma of prioritizing coursework over research (or vice versa) is a common struggle. However, it is essential to introspect and ask yourself, "Am I really busy enough not to pursue both coursework and research?" Interestingly, both pursuits can be compatible. It is important to note that there is no shortcut for publishing a paper. It is not an easy process, but there is a way to overcome it: be asymptotic and persistent.

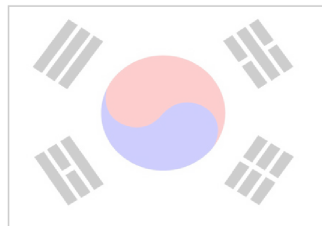

On October 26th, 2023, KOSCA hosted the 4th Korea-US Joint Academic Virtual Conference with **the Korean Criminological Association, the Korean Association for Industrial Security, and the Korean Association of Public Safety and Criminal Justice.**

With the help of our amazing moderator, **Dr. Jae-Seung Lee** (Miami University, Chair of International Committee at KOSCA), This virtual conference started with the opening remarks from **Dr. Hyeyoung Lim** (President of KOSCA; University of Alabama-Birmingham), **Dr. Cheol Hyun Park** (President of Korean Criminological Association; Dong- Eui University), **Dr. Seong Jin Ahn** (President of Korean Association for Industrial Security; Sungkyunkwan University), and from **Dr. Jaepoong Park** (President of Korean Association of Public Safety and Criminal Justice; Korean National Police University Police Science Institute).

# Building Relationship with Community

COYAD is a non-profit organization based in Duluth, GA, dedicated to preventing drug use among youths through leadership training and building a healthy network among youths. Additionally, members of the KOSCA division of Korean Community and Criminal Justice discussed the KOSCA-sponsored research on the Korean

community’s perception of local law enforcement’s legitimacy (Presenter: Dr. Sinyong Choi, Moderator: Dr. Insun Park).
